bewoners. Baie mense vra wat gaan nou daarmee gebeur. Daar is tans 'n regsdispuut oor iemand wat 'n eis daarop het. Ek sal u op hoogte hou met die toekomsplanne daarvoor.

 Water is skaars, uiters skaars. U moet asb mooi werk met water en kennis neem van die beperkings. Kaapstad het reeds vlak 3 beperkings afgekondig en tariewe aangepas. Ons oorweeg ook nou ekstra maatreëls en dit sal voor die Raad dien aan die einde van die maand. Kan alle swembadeienaars asseblief 'n verdampingskombers aanskaf en onthou om slegs tuine vir kort tye en vroeg in die oggend of in die aand nat te maak. Dis belangrik dat ons 'n verdere 15% op verbruik besnoei anders sal ons later glad nie mag tuine natmaak nie. U mag ook asb nie motors was met tuinslange nie. Op munisipale vlak sal ons ook ernstig kyk na besparings.

Ek het verskeie klagtes gekry oor selfoontorings, maar dis 'n komplekse situasie want sommige inwoners dring daarop aan en ander wil dit nie hê nie. Ek het reeds opdrag gegee dat ons dringend 'n beleid in plek moet kry oor seltorings en dit behoort voor die Raad te dien einde November. Daarna sal die publiek kans kry om insette te gee. Daar is ook 'n moratorium op nuwe goedkeurings op ons eie grond totdat die beleid in plek is, maar nasionale en provinsiale wetgewing laat toe dat sekere openbare plekke soos skole die reg het om torings op hul grond te installeer. Ons moet slegs die bouplanne goedkeur.

Franschhoek se inwoners sal baie bly wees om te hoor u kan nou u motorlisensies daar hernu en betaal. Soos belowe, sal ons ook Franschhoek insluit by ons regeringsbesluite.

what will happen to the building now. There is a legal dispute with somebody who now lays claim to it. I will keep you informed on this matter and any future plans.

 Water is scarce, very very scarce. Residents must please take care with water and take note of the restrictions in place. Cape Town has moved to level 3 restrictions and has adjusted their tariffs accordingly. We are also considering implementing additional measures and it will serve before council at the end of the month. All swimming pool owners, please get an evaporation cover for your pool and remember that you are only allowed to water your gardens in the early mornings or in the evenings. It is important that we cut another 15% of our water usage; otherwise we will not be able to water our gardens at all at a later stage. You cannot wash your cars with garden hoses. At a municipal level we are also implementing serious savings.

I have received various complaints about cellular towers. This is however a complex situation because some residents insist on it and others do not want it at all. I have already given the order for the drafting of a policy regarding this matter and it should serve in front of Council by the end of November. After that, the public will get the opportunity to give input. A moratorium has been placed on approvals for cellular towers on municipal properties until the policy is in place, but national and provincial government still allow the installation of towers on certain public spaces such as schools. We only have to approve the building plans.

Franschhoek residents will be glad to learn that you will now be able to renew and pay for motor vehicle licences in Franschhoek. As promised, we will include Franschhoek in all of this government's decisions.
