2. PURPOSE

4. EXECUTIVE SUMMARY

Council approved Grant in Aid donations as part of the Draft MTREF (Budget) 2019-2022 item at the 27th Council meeting on 29 May 2019. 6.1 <u>Background</u>

The municipal budget was approved in draft form during the March 2019 Council meeting. It was then published for comments with a closing date of 30 April 2019.

During this period the municipality received comments and appeals on the recommended Grant in Aid donations which were submitted to Council for consideration in May 2019.

6.2 <u>Discussion</u>

The appeal of Nietvoorbij United Football Club was submitted to the municipality within the prescribed period and provided the required documents in order for the application to comply with all Grant in Aid policy requirements. The appeal was not included in the budget documents due to the fact that the applicant emailed the appeal to an official who was on leave at the time and cc'd the Manager Community Development, but spelled her email address incorrectly. It was thus not received by the Manager Community Development.

The omittance of the appeal was brought under the attention of the Manager Community Development after the other official returned from leave and after the Council meeting.
