

### 6. DISCUSSION / CONTENTS

### 6.1. <u>Background</u>

The core function of the Department Traffic Services is to improve road safety by changing driver behavior. The Department participates in the respective national and provincial road safety and crime prevention campaigns and co-ordinate actions with other law enforcement agencies such as the South African Police Services, Western Cape Provincial Traffic Services within Department of Transport.

The Department Traffic Service Stellenbosch strives within its capacity to achieve the objectives as set out in section 152 of the Constitution. "To promote a safe & healthy environment" for all citizens within the Greater Stellenbosch Municipal Area.

### 6.2 <u>Discussion</u>

Stellenbosch Traffic Services performs 3 functions on behalf of Provincial Department of Transport, namely, Registration and licensing of vehicles, Vehicle Roadworthy tests and Driver/learner testing.

The monthly report entails an activity report which includes statistics on total accidents and its categories of injuries, number of learner and driver licences issued/converted and other related driver authorisation, roadworthy tests conducted and certificates issued, motor vehicle registrations, issue of duplicate registration certificates, annual licence renewals, issue of temporary/special permits and allocation of registration numbers, total notices issued for parking, moving offences and speeding violations. Stellenbosch is well-known for hosting events and ideal location for film shooting. On a monthly basis the Stellenbosch Traffic Services provides assistance at these events which are listed in the report.

Staff members are deployed to increase road safety awareness by conducting campaigns and visiting crèches, primary and high schools colleges and the university. The same unit is all responsible for responding to accidents. Due to SAPS limited staffing, these officers response time is faster to ensure safe-guarding/accurate recording of data/clearing of the accident scene.

The financial management report provides an overview of income generated by divisions as stated above, parking revenue, rental of parking bays, services provided by officers, film shoots, impoundment fees, issue of parking discs and request for data such as copies of accident reports. Further data is provided on Automatic Number-plate recognition operations, locations and income generated. During this period the revenue collected is low due to non-operational of parking management system, licences sections and traffic fines management, all affected by level 5 lockdown regulations of Covid-19 epidemics.



The Department Traffic Service Stellenbosch strives within its capacity to achieve the objectives as set out in section 152 of the Constitution. "To promote a safe & healthy environment" for all citizens within the Greater Stellenbosch Municipal Area.

### 6.2 <u>Discussion</u>

Stellenbosch Traffic Services performs 3 functions on behalf of Provincial Department of Transport, namely, Registration and licensing of vehicles, Vehicle Roadworthy tests and Driver/learner testing.

The monthly report entails an activity report which includes statistics on total accidents and its categories of injuries, number of learner and driver licences issued/converted and other related driver authorisation, roadworthy tests conducted and certificates issued, motor vehicle registrations, issue of duplicate registration certificates, annual licence renewals, issue of temporary/special permits and allocation of registration numbers, total notices issued for parking, moving offences and speeding violations. Stellenbosch is well-known for hosting events and ideal location for film shooting. On a monthly basis the Stellenbosch Traffic Services provides assistance at these events which are listed in the report.

Staff members are deployed to increase road safety awareness by conducting campaigns and visiting crèches, primary and high schools colleges and the university. The same unit is all responsible for responding to accidents. Due to SAPS limited staffing, these officers response time is faster to ensure safe-guarding/accurate recording of data/clearing of the accident scene.

The financial management report provides an overview of income generated by divisions as stated above, parking revenue, rental of parking bays, services provided by officers, film shoots, impoundment fees, issue of parking discs and request for data such as copies of accident reports. Further data is provided on Automatic Number-plate recognition operations, locations and income generated. During this period the revenue collected is low due to non-operational of parking management system, licences sections and traffic fines management, all affected by level 5 lockdown regulations of Covid-19 epidemics.

The traffic operational plan is only made available and reported on after activities took place due to confidential nature thereof.







### KPA 1: INTEGRATED INSTITUTIONAL CAPACITY

The Disaster Management unit is mandated to effectively coordinate the required collective input of the municipality, external stakeholders and citizens.

#### 1.1. PARTICIPATION OF VOLUNTEERS IN THE DEPARTMENT

Disaster Management: EPWP Volunteers participate on regular bases by assisting in conducting educational campaigns and awareness at crèches, communities and at schools about safety and emergency services, capacitate the department by doing field work and conducting the required surveys within communities.

A key function attributed to Disaster Management: EPWP Volunteers is to assist with the incident risk assessments during emergency situations such as fires and floods and the subsequent provision of material and relief aid to the affected. This is all done with the aim to alleviate the effects of a disaster and to restore and to rehabilitate the affected in the shortest possible time.

Volunteers were expected to render administrative support to the superior in the form of feedback-, verification and monthly report, this contributes to skills development.

With the onset of the COVID- 19 pandemic and it being declared a national disaster, it has become incumbent upon the Disaster Management: EPWP Volunteers to monitor and advice the different communities of the Greater Stellenbosch region on appropriate actions and behaviour as well as applicable safety measures during such a crisis. These Volunteers also constantly assist the municipal council area's needy communities by providing them with donations collected from various reputable organisations.

#### 1.2. PARTNERS FOR PROJECT AND ALLIES

The department engages at numerous platforms through partnering stakeholders to gain access to new resources, information, expertise and skills to facilitate service delivery.

#### **1.2.2. EVACUATION DRILLS**

Clear allocations of roles and responsibilities and defined procedures and protocol for all operational personnel is influenced by mechanisms in place which leave no room for confusion when significant events or disasters occurs or is threatening to occur in municipal council's area.

The Disaster Management Act provides a platform from which all spheres of government and communities can work together to prevent or reduce the risks of disasters including steps which are aimed at-

- > preventing or reducing the risk of disasters;
- taking measures to reduce the impact or consequences of a disaster;
- emergency preparedness;
- > rapid and effective responses to disasters; and
- > post- disaster recovery and rehabilitation.

#### 1.3. NODAL POINTS

The effectiveness of communication between the disaster management office and ward offices are very vital as these offices tend to be the central point of information during disaster related incidents. The Disaster Management Unit is assigned the task of directing and facilitating the disaster risk management process.

This process remains on-going.



Early warnings are closely watched to ensure rapid response actions by essential and emergency services; accessibility to household, communities and areas that are at risk; avert potential impact to people, loss of life, damage to property.

Response to any disaster related incident whether it is dealing with damage from fires, floods or severe storms need to consider your personal safety first as your survival depends on you.

#### b) SA WEATHER SERVICES

South African Weather Services through Cape Winelands District Disaster Management office effectively issued hazard warnings of significance for the municipal area timely ensuring these warnings include information and guidance enabling those at risk to increase their safety and to take risk avoidance measures in order to reduce losses. Emergency services remained on high alert for any notification of occurrences to render support.

#### 4.3. EVENTS MANAGEMENT

Emergency services, i.e. municipal law enforcement, traffic, disaster management, fire safety, health and waste management form part of the events committee. The respective roles and responsibilities are clearly defined in the Safety at Sports and Recreational Events Act, 2010. This committee plays a critical role in overseeing events, the safe guarding of premises as well as of participants.

Several events approved and hosted in WCO24 complied to safety standards and regulations. Weekly scheduled meeting between emergency services continued for upcoming activities/ events in Greater Stellenbosch. Joint operations centre (JOC) and Venue operations centre (VOC) was fully represented by emergency stakeholders, i.e.: Events Organizer/ Safety Officer, SAPS/ Security, Disaster Management, EMS.

Between the Departments: Fire Prevention and Disaster Management, events safety inspections are conducted to ensure compliance to safety standard and regulations.

#### ENABLER 2: EDUCATION, TRAINING, PUBLIC AWARENESS AND RESEARCH

Public Awareness has long been regarded as one of the tool to achieve disaster risk reduction through increased hazard knowledge risk perception and fostering of risk avoidance behavior

These awareness campaign aims to reach those most vulnerable to the impact of such hazards and focuses on residents in informal settlements and primary school learners in the respective areas.



#### KPA 1:

#### INTEGRATED INSTITUTIONAL CAPACITY

(1) Each metropolitan and each district municipality must establish and implement a framework for disaster management in the municipality aimed at ensuring an integrated and uniform approach to disaster management in its area.

(2) A district municipality must establish its disaster management framework after consultation with the local municipalities in its area. A municipal disaster management framework must be consistent with the provisions of this Act, the national disaster management framework and the disaster management framework of the province concerned.

#### 1.1. PARTICIPATION OF VOLUNTEERS IN THE DEPARTMENT

The disaster regulations makes provision for the establishment of a disaster management volunteer unit. In order to maintain an inclusive approach to the participation of volunteers in the disaster risk management, volunteers are classified into three categories. These categories are:

- Units of volunteers
- General volunteers
- Spontaneous volunteers

#### 1.2. PARTNERS FOR PROJECT AND ALLIES

The department engages at numerous platforms through collaboration with stakeholders to gain access to new resources, information, expertise and skills to facilitate service delivery.

#### 1.2.1 Western Cape Government:

Each province must establish and implement a framework for disaster management in the province aimed at ensuring an integrated and uniform approach to 35-disaster management in the province by all provincial organs of state, provincial statutory functionaries. Non-governmental organizations involved in disaster management in the province and by the private sector.

#### **1.2.3. EVACUATION DRILLS**

The purpose of conducting an emergency evacuation training drill is to assist personnel to know their roles and responsibilities in an emergency in accordance with the workplace plans and procedures, and to test the workforce response to an emergency.

The Disaster Management Act provides a platform from which all spheres of government and communities can work together to prevent or reduce the risks of disasters including steps which are aimed at–

- > preventing or reducing the risk of disasters;
- > taking measures to reduce the impact or consequences of a disaster;
- emergency preparedness;
- > rapid and effective responses to disasters; and
- > post-disaster recovery and rehabilitation.

#### 1.3. NODAL POINTS

The senior coordinator: Disaster Management of the Stellenbosch Municipality must direct and facilitate the disaster risk management process. However, this incumbent cannot perform the whole spectrum of disaster risk management activities on his/her own. Disaster Management is not a line function, but an advisory coordinative function. Disaster risk management is everybody's business. It is required that each municipal discipline within the Municipality assigns a person or section within each discipline to be the nodal point for disaster management activities in that particular discipline. The disaster management activities performed within disciplines include participation in disaster risk reduction strategies as well as preparedness and response.

#### 1.4. MUNICIPAL DISASTER MANAGEMENT FRAMEWORK

#### 1.4.1 Have any disaster management plans and contingency plans have been updated?

## 1.4.2 Did stakeholder engagements take place to establish a cooperative with mechanisms?

THE GOAL is to provide a platform for local governments, disaster management,

Civil society groups, businesses, academic institutions, and other interested groups to demonstrate support and to highlight achievements and challenges in so doing with a particular focus on life-saving measures.

Stellenbosch municipality is part of the bi weekly CWDM consultative disaster structure. Many statutory bodies and stakeholders is represented on this body where strategies to combat the spread of the Corona virus is formulated.

The Health department in collaboration with Stellenbosch municipality has commenced with the the vaccination drive in the Stellenbosch area.

The protection services did also play an active part in the Child protection week.

#### KPA 2: RISK ASSESSMENT

#### 1. DISASTER RISK ASSESSMENT

A disaster risk assessment is a qualitative or quantitative approach to determine the nature and extent of disaster risk by analyzing potential hazards and evaluating existing conditions of exposure and vulnerability that could be detrimental to people, property, services, livelihoods and the environment on which they are dependent.

Stellenbosch municipality in collaboration with the Cape Winelands District Municipality conducted a ward based risk assessment (spanning over 24 months) for the entire WC024 area.

#### 2.1 Fires

The disaster management unit dealt with the assessment of various types of fires. Consistent with seasonal trends, most of these fire occurrences affected informal dwellings

#### PLANNED PROJECT:

A Total of 598 Firekilla disposable fire extinguisher have been ordered as part of a pilot program to assist in combatting runaway fires in informal settlements. Fire prone areas will be identified for the launch and roll out of the program.



The Fire Killa Extinguisher is a class A extinguisher with nontoxic ingredients, which is easily operated by the user with simple to follow instructions on the bottle.

The unit comprises a 4-litre injection moulded robust plastic bottle containing 2.5 litres solution of our formula, foaming agent and water. A built in cartridge contains 180 grams of activator, which when required, is released into the water by means of a hand-activated plunger. This produces approximately 10 litres of foam, which is dispensed through a nozzle at a rate of about one litre per second. The foam cools and smothers the flame. A safety clip is fitted around the plunger shaft to prevent accidental activation. When required, the clip is easily removed by pulling on the clip ring.

Once used, the unit can be recharged with the activator cartridge, and the formula / foaming agent / water solution. The unit when fully charged weighs approximately 3.5 kg's. The Fire Killa Extinguisher is not under pressure until activated and does not require regular inspection. After use, the unit should be taken to an appointed service centre to be recharged. Fire Killa Extinguisher is a non-pressurized, reusable unit.





#### KPA 1: INTEGRATED INSTITUTIONAL CAPACITY

The Disaster Management unit is to effectively coordinate the required collective input of the municipality, external stakeholders and citizens.

#### 1.1. PARTICIPATION OF VOLUNTEERS IN THE DEPARTMENT

Disaster Management: EPWP Volunteers participates on regular bases by assisting in conducting educational campaign and awareness at crèches, communities and at schools about safety and emergency services.

#### 1.2. PARTNERS FOR PROJECT AND ALLIES

The department engages at numerous platforms through partnering stakeholders to gain access to new resources, information, expertise and skills to facilitate service delivery.

#### **1.2.1. EVACUATION DRILLS**

Clear allocations of roles and responsibilities and defined procedures and protocol for all operational personnel is influenced by mechanism in place which leaves no room for confusion when significant event or disaster occurs or is threatening to occur in municipal council's area.

The Disaster Management Act provides a platform from which all spheres of government and communities can work together to prevent or reduce the risks of disasters including steps which are aimed at–

- > preventing or reducing the risk of disasters;
- > taking measures to reduce the impact or consequences of a disaster;
- emergency preparedness;
- > rapid and effective responses to disasters; and
- > post-disaster recovery and rehabilitation.

#### 1.3. NODAL POINTS

The effectiveness of communication between disaster management office and ward offices are very vital as these offices tend to be central point of information during disaster related incidents. The Disaster Management Unit is assigned the task of directing and facilitating the disaster risk management process.

This process remains on-going.

#### 2.2 Strong winds

**Strong damaging winds** -: The SA Weather Service (SAWS) has warned of gale force winds, with possible gusts of 100km/h over parts of Western as well as disruptive rainfall in Cape Winelands. A storm warning of Orange level 8, to indicate the severity of the wind, which could be expected for few days.

"The SAWS warns that strong to gale north-westerly winds, with intense gusts (100-140km/h), can be expected over the interior of the province".

Cape Winelands is predicted to be missing the worst of the wind. However, the SAWS has issued an Orange level 6 warning for rainfall for the area, conditions that are expected to remain until the beginning of July 2021

Widespread damage to formal and informal settlements was likely as well as the disruption of essential services.

#### 2.3 Flood/Roof Leak

**Flooding -:** Since the cold front had moved in, there had been heavy rains across the district the past month. Informal settlements has been severely impacted and Roads and Stormwater and Fire Services personnel responded to many of these complaints. Sandbags was stacked in an effort to divert runoff water away from residences.

South African Weather Services through Cape Winelands District Disaster Management office effectively issued hazards warning of significance for the municipal area. Emergency services adhered to this early warnings and prepared accordingly with filling of sandbags, placing sandbags at historic flood prone areas and the maintenance of storm water systems.

#### 4.3. EVENTS MANAGEMENT

Emergency services, i.e., municipal law enforcement, traffic, disaster management, fire safety, health and waste management form part of the event's committee. The respective roles and responsibilities are clearly defined in the Safety at Sports and Recreational Events Act, 2010. This committee plays a critical role in overseeing events. All events is approved subject to and in accordance with prevailing Lockdown level.

#### ENABLER 2: EDUCATION, TRAINING, PUBLIC AWARENESS AND RESEARCH

COVID-19 vaccines provide protection against developing severe disease and death, but it does not provide 100% protection against infection, and for that matter, transmission to others. For these reasons, those who have been inoculated should continue following preventative measures, which include the wearing of facemasks that covers both the nose and mouth, washing hands frequently or using an alcohol-based hand sanitiser, maintaining physical distancing of 1.5m or more where possible, avoiding crowds and gathering in well ventilated spaces, if not outdoors.

Department of Health confirms that a significant majority people over the age of 60 had received the jab, which translated to 40% of the population in that age group.



#### BACKGROUND

The Restorative Justice Project report covers the period from 01<sup>st</sup> May 2021 till 31<sup>st</sup> May 2021 This project concentrates on displaced people who are contravening municipal by-laws and provides feedback on warrants executed received from the Municipal Court.

#### Challenges faced this past month

Community Development still does not have programs for displaced persons. No social worker to assist with displaced persons. Members of Community Development could not come to court on a few days to assist due other commitments.

Monthly Summary for May 2021

During the month of May 2021 Thirteen (13) displaced persons were brought to the municipal court as part of the restorative justice program after being found contravening the municipal by-laws, most of the homeless persons were brought to court on days that the members of community development members were not present at court because they only available two (2) days a week on a Wednesday and Friday of each week.

- The homeless people that were brought to court for contravening the municipal bylaws was warned and referred to see the members of community development to be put into programs.
- Two (2) of the displaced person was referred to Abba rehab Centre due to drug addiction and was interviewed by Abba.
- One (1) of the homeless persons was accepted by the Salvation Army Hesketh King Treatment Centre and reported to the rehab Centre on the 25<sup>th</sup> May 2021.
- One (1) homeless person was referred to the Stellenbosch hospital because of illness and was warned to come for a follow up session with community development members when discharged from hospital.
- A female that also ended up on the street with her Four (4) year old daughter was also warned to get her child of the Street otherwise the child welfare will be involved

and the lady with her four (4) year old daughter was fetched by her family from Eersteriver.

- Two (2) displaced persons that were sleeping on the street was referred to the night shelter and was accepted.
- Four (4) homeless persons that were sleeping at the Bergzicht Taxi rank at the washing bay and causing a nuisance and disturbance was verbally warned by the Stellenbosch Municipal Court's prosecutor to immediately cease their behaviour or otherwise face prosecution. Material that was used to erect structures was also seized.
- Two (2) of the displaced persons that were warned did not come to court to be interviewed by members of community development.
