Property Rates Rebate : 2019/2020

With reference to Council's Property Rates Policy, **all applications for property rates rebates must be submitted not later than 30 November 2018 for the 2019/2020** financial year.

For **budget purposes** all qualifying organizations and individuals are kindly requested to collect the necessary application form from any of the municipal administrative offices or Council's website www.stellenbosch.gov.za for submission on/before **30 November 2018 at the Rates Section**.

The under mentioned organizations and individuals may qualify for a rebate:**[Also see paragraph 8 (relief measures) of Council's Property Rates Policy]**.

1. Non Profit Organizations
2. Pensioners 60 years and older (**Gross monthly income less than R 15 000**)
3. Disabled owners

Very Important: All supporting documentation must be attached to your application.

- **SENIOR CITIZENS AND DISABLED PERSONS:** Copy of ID, Proof of Income, and 3 months' bank statements.
- **NON- PROFIT ORGANISATIONS:** Sars - , NPO registration where applicable, most recent audited financial statements
