GESTETNER SALES TERMS AND CONDITIONS

All words appearing in these terms and conditions with capital initial letters refer to the description overleaf. The word "you" and the derivatives are used to mean Gesteiner.

We agree to:

- (a) Maintain the equipment in an efficient operating condition during the currency of this agreement. We shall not be liable for any loss of business or profit, including consequential loss arising from the maintenance of the equipment to function, or for failure to provide service or supplies due to causes beyond our control. Any service or repairs required by you due to misuse or negligence or outside any normal working hours may at our option, be charged to you in accordance with our current service charges and conditions:
 - (b) supply developer and toner at our preferred prices applicable at the date of delivery of such consumables.

You agree to:

- (a) pay amounts due to us within thirty (30) days of date of invoice, failing which we may summarily and without notice suspend the supply of service and consumables until all outstanding amounts due to us are paid;
- (b) use only paper, consumables and software approved by us in equipment;
- (c) pay us at the rate specified in this agreement, such rate being, inclusive of service. This rate may be varied in accordance with our current pricing schedules;
- (d) provide two persons as 'principal operators' for the equipment and we will train them in its use. You shall notify us in writing of any change in these personnel;
- (a) supply us in a manner determined by us from time to time, with meter readings for the equipment, meter readings shall be obtained quarterly unless otherwise stated.
- (f) that it is a specific term of this agreement that Electonic Meter Reading Equipment ("Herda system") be supplied and installed on the equipment, for the purposes of accurately recording and gathering information pertaining to the rate at which the machine is utilised in
- (g) pay a penalty of _____ cent extra per copy for every copy made in accordance with the meter reading equipment supplied and installed by yourselves in the event of you electing not to install the Herda System. Should no meter reading equipment be installed then this agreement.

Maintenance service does not include:

- (a) Repair and damage or increases in service time resulting from force majeure, fire, water, lightning, surges in main electricity supply, accident, neglect, misuse or use other than that for which the equipment is designed, failure of electrical power, airconditioning or humidity control.
- (b) Movement of the equipment from the original location. Any such movement must be requested two weeks prior to the planned move in writing and will be charged to you in accordance with our current service charges.
- (c) Service, travelling or parts outside of our normal working hours Mondays to Fridays (excluding public holidays) 08h00 to 16h30.
- (d) Toners in respect of fax machines nor the master units for any agreement that excludes toner.

4. Duration of Agreement:

- 4.1 This agreement shall commence on installation of the equipment and shall continue for the period as indicated under "Contract Period" overleaf and thereafter for an indefinite period subject to the right of either of us to terminate the agreement upon not less than 90 days equipment.
- 4.2 Should either party elect to cancel this agreement in accordance with the provisions of paragraph 4.1 above and the equipment so supplied is subject to a rental agreement then any letter of cancellation must be accompanied by a letter of authority from the finance house, institution

5. Breach

- (a) In the event where you commit a breach of any of your obligations under this agreement then without prejudice to any other remedy that we may have including the right to cancel this agreement, we shall be entitled to suspend further performance of our obligations until the
- (b) For purposes of jurisdiction the parties submit themselves to the jurisdiction of the Johannesburg Magistrates Court and consents in terms of section 45 of such act to the jurisdiction of such court notwithstanding the fact that the amount of such claim may exceed the jurisdiction
- (c) If you are in breach of any of your obligations under this agreement then without prejudice to any other remedy we may have including the right to cancel this agreement, we shall be entitled to suspend further performance of our obligations until the breach is remedied.

Cessio

This agreement may not be ceded, assigned or in any other way transferred to any third party without the express written consent of Gestetner which written consent shall not be unreasonably withheld.

Entire Agresment

The terms hereof represent the entire agreement in respect of the subject matter contained herein and no variation of, addition to or amendment of this agreement will be of any force or effect unless reduced to writing and signed by both parties.
