

All words appearing in these terms and the word "we" and its derivatives are used to mean the Customer and the word "we" and its derivatives are used to mean Gestetner.

We soree to:

- (a) Maintain the equipment in an efficient operating condition during the currency of this agreement. We shall not be liable for any loss of maintain the equipment in an existent operating condition during the currency of this agreement, we shall not be liable for any loss of business or profit, Including consequential loss arising from the malfunction or failure of the squipment to function, or for failure to provide service or supplies due to causes beyond our control. Any service or repairs required by you due to misuse or negligence or outside any normal working hours may at our option, be charged to you in accordance with our current service charges and conditions;
 - (b) supply developer and toner at our preferred prices applicable at the date of delivery of such consumables.

2 You agree to:

- pay amounts due to us within thirty (30) days of date of involce, failing which we may summerily and without notice suspend the supply of (a) service and consumables until all outstanding amounts due to us are paid;
- (b) use only paper, consumables and software approved by us in equipment;
- pay us at the rate specified in this agreement, such rate being, inclusive of service. This rate may be varied in accordance with our current
- (d) provide two persons as 'principal operators' for the equipment and we will train them in its use. You shall notify us in writing of any change
