A **Compulsory Clarification Meeting** will be held on **14 April 2025 at 10h00**. The Compulsory Clarification meeting will be held in person at Stellenbosch Municipal Library Hall, 1st Floor Plein Street, Stellenbosch.

This is a rates-based tender and the quantities provided in the Schedule of Quantities for this tender will be used to generate a tender value for the financial offer for the purposes of tender evaluation. The tender value does not necessarily reflect the total value of work to be awarded or limit the total work to be awarded.

Since the work is of a routine and repetitive nature, as per the Construction Industry Development Regulations, Inform Practice Note #3, August 2006 (Version 2 - February 2008), the CIDB contractor grading designation is based on the annual estimated value of the contract.

Tenders may only be submitted on the Tender documentation issued by Stellenbosch Municipality and must be valid for **180 days** after tender closing. Late, electronic format, telephonic or faxed Tenders will not be considered and Stellenbosch Municipality does not bind itself to accept the lowest bid or any of the tenders that has been submitted.

Sealed Tenders, with “**B/SM 105/25: DOMESTIC LEAK REPAIR, WATER METER REPLACEMENT AND PRESSURE MANAGEMENT**” clearly endorsed on the envelope, must be deposited in the Tender box at the offices of the Stellenbosch Municipality, Plein Street, Stellenbosch. The Tender box is accessible 24 hours a day. The completed Tender Document (hardcopy) must accompany tenders, as well as a **USB memory stick** containing a **scanned copy of the whole completed Tender Document in pdf format** (softcopy) and a **whole completed Bill of Quantities in Excel format** (softcopy). Should there be any discrepancy between the tenderer’s hardcopy and softcopies, the hardcopy document shall take precedence. Any contract shall be based on the tenderer’s hardcopy Tender Document. Tenders not accompanied by a complete hardcopy Tender Document, will not be considered.

NOTE: This tender will be evaluated in terms of the **General Conditions of Contract, Supply Chain Management Policy, relevant specification and functionality as depicted in the document and also the Preferential Procurement Regulations, 2022 that was promulgated by the Minister of Finance on 4 November 2022 in Government Gazette No 47452.**

3. Tenderers must be registered on the Central supplier database (CSD) and must be registered on Stellenbosch Municipality’s supplier database if they wish to conduct business within the municipality
4. No award will be made to tenderers whose tax status is non-compliant

5. Tenders submitted must be in a sealed envelope clearly marked with the Tender number, placed in the tender box before closing time. Failure will result in the tender being invalid

POPIA

By submitting a tender to the Stellenbosch Municipality, (and by concluding any ensuing related agreement with the Stellenbosch Municipality, if applicable), the Tenderer thereby acknowledges and unconditionally agrees:

- 1.1. that the tenderer has been informed of the purpose of the collection and processing of its personal the avoidance of doubt is for, and in relation to, the tender process and the negotiation, conclusion, performance and enforcement of the ensuing agreement, if applicable, as well as for the Stellenbosch Municipality's reporting purposes;
- 1.2. to the collection and processing of the tenderer's personal information by the Stellenbosch Municipality and agrees to make available to the Stellenbosch Municipality, all information reasonably required by the Stellenbosch Municipality for the above purposes;

Die Verpligte Toeligtingsvergadering sal by Stellenbosch Munisipale Biblioteeksaal, 1ste Vloer, Pleinstraat gehou word.. Tendersaars wat nie die verpligte inligtingsessie bywoon nie, sal nie in ag geneem word nie.

Hierdie is 'n tarief-gebaseerde tender en die hoeveelhede wat verskaf is in die hoeveelheidslys van die tender sal gebruik word om die tenderwaarde te bepaal vir die finansieële offer vir die doeleindes vir tenderevaluering.
