6. GENERAL CONDITIONS OF CONTRACT – GOVERNMENT PROCUREMENT

1. DEFINITIONS

The following terms shall be interpreted as indicated:

- 1.1. "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2. "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3. "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4. "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5. "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally
- 1.6. "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7. "Day" means calendar day.
- 1.8. "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9. "Delivery ex stock" means immediate delivery directly from stock actually on hand
- 1.10. "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11. "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12. "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable.
- 1.13. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.14. "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.15. "GCC" means the General Conditions of Contract.
- 1.16. "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.17. "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.18. "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.



- 1.19. "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.20. "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.21. "Project site" where applicable, means the place indicated in bidding documents.
- 1.22. "Purchaser" means the organization purchasing the goods.
- 1.23. "Republic" means the Republic of South Africa.
- 1.24. "SCC" means the Special Conditions of Contract.
- 1.25. "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.26. "Supplier" means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
- 1.27. "Tort" means in breach of contract.
- 1.28. "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
- 1.29. "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

2. Application

- 2.1. These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2. Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3. Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1. Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2. Invitations to bid are usually published in locally distributed news media and on the municipality / municipal entity website.

4. Standards

- 4.1. The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information; inspection.

- 5.1. The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only as far as may be necessary for purposes of such performance.
- 5.2. The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3. Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.



- 5.4. The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights

- 6.1. The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
- 6.2. When a supplier developed documentation / projects for the municipality / municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality / municipal entity.

7. Performance security

- 7.1. Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2. The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3. The performance security shall be denominated in the currency of the contract or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
- 7.3.1. bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
- 7.3.2. a cashier's or certified cheque
- 7.4. The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified.

8. Inspections, tests and analyses

- 8.1. All pre-bidding testing will be for the account of the bidder. If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspections tests and analysis, the bidder or contractor's premises shall be open, at all reasonable hours, for inspection by a representative of the purchaser or an organization acting on behalf of the purchaser.
- 8.2. If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.3. If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.4. Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.5. Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.



- 8.6. Any contract goods may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.
- 8.7. The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 22 of GCC.

9. Packing

- 9.1. The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2. The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, and in any subsequent instructions ordered by the purchaser.

10. Delivery

Delivery of the goods shall be made by the supplier in accordance with the documents and terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified.

11. Insurance

The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified.

12. Transportation

Should a price other than an all-inclusive delivered price be required, this shall be specified.

13. Incidental

- 13.1. The supplier may be required to provide any or all of the following services, including additional services, if any:
- 13.1.1. performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - 13.1.2. furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - 13.1.3. furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - 13.1.4. performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
 - 13.1.5. training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2. Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.



14. Spare parts

- 14.1. As specified, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
- 14.1.1. such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and;
- 14.1.2. in the event of termination of production of the spare parts:
- 14.1.2.1. advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
- 14.1.2.2. following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

- 15.1. The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.2. This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.
- 15.3. The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4. Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5. If the supplier, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment

- 16.1. The method and conditions of payment to be made to the supplier under this contract shall be specified.
- 16.2. The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3. Payments shall be made by the purchaser **no later than thirty (30) days** after submission of an **invoice, statement** or claim by the supplier.
- 16.4. Payment will be made in Rand unless otherwise stipulated.

17. Prices

Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized or in the purchaser's request for bid validity extension, as the case may be.

18. Variation orders

In cases where the estimated value of the envisaged changes in purchase does not vary more than 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the contractor may be approached to reduce the unit price and such offers, may be accepted provided that there is no escalation in price.



19. Assignment

The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts

The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract, if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the supplier's performance

- 21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- 21.4. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22 without the application of penalties.
- 21.5. Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

- 23.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
 - 23.1.1. if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - 23.1.2. if the Supplier fails to perform any other obligation(s) under the contract; or
 - 23.1.3. if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.



-
- 23.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4. If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.
- 23.5. Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchase actively associated.
- 23.6. If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
- 23.6.1. the name and address of the supplier and / or person restricted by the purchaser;
- 23.6.2. the date of commencement of the restriction
- 23.6.3. the period of restriction; and
- 23.6.4. the reasons for the restriction.
- These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.
- 23.7. If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

25. Force Majeure

- 25.1. Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2. If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency



The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

- 27.1. If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2. If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3. Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4. Notwithstanding any reference to mediation and/or court proceedings herein,
 - 27.4.1. the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - 27.4.2. the purchaser shall pay the supplier any monies due for goods delivered and / or services rendered according to the prescripts of the contract.

28. Limitation of liability

- 28.1. Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;
 - 28.1.1. the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
 - 28.1.2. the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment

29. Governing language

The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable law

The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

31. Notices

- 31.1. Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice
- 31.2. The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties

- 32.1. A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2. A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3. No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.

- 32.4. No contract shall be concluded with any bidder whose municipal rates and taxes and municipal services charges are in arrears.

33. Transfer of contracts

The contractor shall not abandon, transfer, cede, assign or sublet a contract or part thereof without the written permission of the purchaser.

34. Amendment of contracts

No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.

35. Prohibition of restrictive practices.

In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is / are or a contractor(s) was / were involved in collusive bidding.
- 35.2. If a bidder(s) or contractor(s) based on reasonable grounds or evidence obtained by the purchaser has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in section 59 of the Competition Act No 89 Of 1998.
- 35.3. If a bidder(s) or contractor(s) has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.

- 3.5. Reporting: Submit patrol logs, incident reports, and performance summaries weekly, monthly, quarterly, and annually. Provide GPS tracking data for all patrol vehicles monthly or upon request.
- 3.6. Resources and Equipment: Maintain trained PSIRA-registered officers, supervisors, and vehicles with GPS and communication equipment.
- 3.7. Health, Safety, and Environmental Compliance: Ensure PPE and adherence to OHS Act and Municipal Bylaws.
- 3.8. Conduct and Ethics: Respect dignity and rights of individuals and comply with the Constitution, PIE Act, and relevant legislation.

4. MONITORING

- 4.1. Patrolling and monitoring shall be conducted by vehicle in two (2) shifts of twelve (12) hours each. The first shift will operate from 07h00 to 19h00, and the second shift from 19h00 to 07h00.
- 4.2. The appointed service provider shall patrol and monitor all identified and non-identified informal settlements within the WC024 jurisdiction on a continuous 24-hour basis.
- 4.3. The appointed service provider shall conduct vehicle patrols and, where necessary, inspections on foot or by drone of all buildings and/or properties owned by the Stellenbosch Municipality, as well as those owned by Provincial or National Government.
- 4.4. The appointed service provider shall also patrol and monitor areas outside informal settlements that are under threat of invasion.

5. PREVENTION OF ILLEGAL INVASIONS AND OCCUPATION

- 5.1. The appointed service provider shall prevent invasions in areas outside informal settlements that are under threat.
- 5.2. The appointed service provider shall prevent any person(s) from illegally erecting structures or dwellings of any kind on land, property, or buildings belonging to any of the entities identified in this tender.
- 5.3. In the event of an attempted invasion or occupation, the appointed service provider shall issue a formal warning notice, generated by the user department, which must be complied with immediately by the person(s) concerned.

- 5.4. All incidents arising under clauses 5.1 and 5.2 shall be documented with photographic evidence to support the issuing of the notice. Such evidence must be submitted in printed format to the user department for record-keeping purposes. This documentation shall form part of the Service Level Agreement (SLA) to support verification and certification of invoices received.
- 5.5. The appointed service provider shall report any illegal invasion or occupation to the Stellenbosch Municipal Control Room within thirty (30) minutes of identification.

6. DEMOLITION

- 6.1. All demolition and removal operations shall comply with the Occupational Health and Safety Act (Act 85 of 1993) and all relevant environmental bylaws. Personal Protective Equipment (PPE) shall be worn at all times. Waste materials and debris must be disposed of at licensed landfill sites.
- 6.2. Demolition and removal of any structure shall only be executed upon written/oral instruction from the Stellenbosch Municipality and/or upon confirmation that a lawful court order or municipal authorization is in effect.
- 6.3. The appointed service provider shall demolish all structures or dwellings (complete, incomplete, or extensions) erected on any land or premises belonging to the entities identified in this tender, after a warning notice has been issued. In the event of a person(s) not adhering to the warning notice stipulations, the appointed service provider will be responsible to demolish any incomplete structures/dwellings being erected before completion thereof. Should such a structure/dwelling be completed and occupied, the service provider must submit a report with a copy of the issued warning notice and his/her sworn statement involved, to the user department as per the reporting clause.
- 6.4. In the event that person(s) fail to comply with the stipulations of a warning notice, the appointed service provider shall demolish any incomplete structures or dwellings before completion thereof. Should such a structure or dwelling be completed and occupied, the service provider shall submit a report to the user department, including a copy of the issued warning notice and a sworn statement by the responsible officer, in accordance with the reporting clause.
- 6.5. Any materials collected during the demolition of structures or dwellings shall be transported by the service provider to a storage facility identified by the user department. Confiscated materials must be marked or labelled with the information of the occupier or illegal occupant, if known, and shall remain the property of the Stellenbosch Municipality. Such materials may not be sold, re-used, disposed of, or returned to the location from which they were confiscated without written authorization from the user department.
- 6.6. Any materials collected during demolition conducted under authority of a court order issued by a competent court shall be marked or labelled and stored separately from other

- confiscated materials. A report detailing such materials, including information of the occupier or illegal occupant, shall be submitted to the user department for record purposes.
- 6.7. In the event of large-scale or violent invasion situations, the service provider shall immediately notify the user department and activate an approved stabilizing plan and unit within thirty (30) minutes. The stabilizing unit shall consist of properly trained security officers equipped with anti-riot gear, shotguns with rubber rounds, and a truck of not less than three (3) tons to assist in demolishing structures or dwellings and loading/off-loading confiscated materials. In cases of large-scale relocation operations or demolitions, a truck of not less than five (5) tons is to be used to ensure operational efficiency. All confiscated materials must be marked or labelled with the information of the occupier or illegal occupant and submitted in a report format to the user department for record purposes.
- 6.8. Early-stage markings or preparatory materials on any land under threat of invasion shall be removed by the appointed service provider upon instruction from the user department. Such materials must be loaded at the location, transported, and off-loaded at the storage facility identified by the user department.
- 6.9. Payment shall only be made for the demolition of incomplete, complete, or extended structures or dwellings, upon receipt of supporting evidence and a valid invoice. Poles, stones, or other materials used for land markings and subsequently removed shall not be considered for payment, unless specifically requested by the user department. In such cases, the appointed service provider shall load, transport, and off-load the materials at a designated area, and payment shall be made per kilometre travelled. Proof of kilometres travelled must accompany the invoice.
- 6.10. Any materials collected during the demolition of structures or dwellings shall be transported by the appointed service provider to a storage facility designated by the user department. All confiscated materials must be clearly marked or labelled with the details of the occupier or illegal occupant, if known, and shall remain the property of the Stellenbosch Municipality. Such materials may not be sold, re-used, disposed of, or returned to the location from which they were confiscated without prior written authorization from the user department.
- 6.11. Any materials collected during demolition conducted under the authority of a court order issued by a competent court shall be marked or labelled and stored separately from other confiscated materials. A detailed report on such materials, including the information of the occupier or illegal occupant, shall be submitted to the user department for record-keeping purposes.

7. RELOCATION AND REBUILDING

7.1. The appointed service provider shall be responsible for the relocation of all structural materials confiscated during demolition. Where applicable, the service provider shall also undertake the rebuilding of any structures or dwellings in accordance with an order issued by a competent court, and ensure such rebuilding is carried out at a designated area identified by the user department.

8. RESOURCES

8.1. Personnel

- 8.1.1 The appointed service provider shall provide the following personnel, as requested by the user department, per identified area for the duration of the contract period:
- (a) A minimum of one (1) full-time PSIRA-registered Grade-C supervisor, with a vehicle, per shift for the entire WC024 jurisdiction.
 - (b) Two (2) full-time PSIRA-registered Grade-D security officers, with a vehicle, per shift for each identified area.
 - (c) One (1) full-time PSIRA-registered Grade-B (minimum) manager, responsible for resolving any issues that may arise, attending meetings on behalf of the appointed service provider, providing effective feedback, and submitting reports and invoices in due time or upon request (see Reporting Clause).
- 8.1.2. All security officers and supervisors engaged under this contract shall support and assist Municipal Law Enforcement officers and shall not act independently in any demolition or arrest.
- 8.1.3. All personnel shall be equipped and dressed in full company uniform suitable for both winter and summer seasons. Uniforms must display the company's name, logo, and prescribed insignia to clearly identify security officers and supervisors. Personnel must always carry their PSIRA registration cards while on duty.
- 8.2. Within thirty (30) days of appointment, the successful service provider shall submit criminal background checks for all employees to the Deputy Chief of the user department, or his/her delegated representative. This requirement applies to all security officers and supervisors working on properties falling within the parameters of this contract and within the jurisdiction of the Stellenbosch Municipality. The cost of such background checks shall be borne by the service provider.
- 8.2.2. Security officers and supervisors must be proficient in reading, writing, and speaking at least two (2) of the official languages of the Western Cape. They must also be physically fit and mentally sound.

- 8.2.5. Security officers and supervisors must conduct effective patrols within the designated areas.

8.3. Equipment Requirements

8.3.1 Provision of Equipment

The appointed service provider shall, for the full duration of the contract, provide and maintain the following equipment:

- One (1) Light Delivery Vehicle (LDV) with an open canopy per identified area (4x4 vehicles are recommended).
- One (1) remote-controlled or hand-operated spotlight securely attached to each vehicle.
- Two (2) crowbars per vehicle.
- One (1) sledgehammer per vehicle.
- One (1) axe per vehicle.
- A minimum of one (1) company-issued cellular phone per vehicle. The contact number of each cellular phone must be submitted to the Stellenbosch Municipality's control room. 8.3.2 Patrol Vehicle Availability

The service provider shall ensure that a patrol vehicle is available at all times during each shift to patrol the designated area.

8.3.3 Vehicle Costs and Maintenance

The service provider shall be solely responsible for all running costs, maintenance, and repairs of vehicles used in the execution of contractual duties. The Stellenbosch Municipality shall not be held liable for any unforeseen increases in costs, including but not limited to fuel price fluctuations or equipment expenses.

8.3.4 GPS Tracking

All vehicles provided by the service provider must be fitted with an active GPS tracking system. Reports generated by the tracking system must be submitted to the user department on a monthly basis or upon request.

8.3.5 Liability Disclaimer

The Stellenbosch Municipality shall not be held responsible for any damage, theft, loss, injury, death, or threats suffered by the service provider or its personnel during the execution of duties for the duration of this contract.

9 REQUIREMENTS

9.1 Bid Submissions

9.1.1 Bidders shall submit a comprehensive contingency plan with their bid documents. The plan must ensure uninterrupted security services in the event of emergencies, unforeseen incidents, or operational disruptions. At a minimum, the plan shall address:

- Staffing shortages
- Vehicle breakdowns
- Equipment failure
- Power outages
- Extreme weather conditions
- Any other incidents that may affect operational effectiveness

The contingency plan must include alternate deployment arrangements, backup communication systems, rapid response protocols, and escalation procedures.

9.1.2 Bidders shall provide a copy of the company's valid PSIRA registration, together with a list of officers, supervisors, and managers, including their respective PSIRA grades.

9.1.3 Proof of public liability insurance to a minimum value of R10 million must be submitted with the bid documents.

9.1.4 Proof of registration with the Compensation for Occupational Injuries and Diseases Act (COIDA) Commissioner must be included in the bid submission.

9.2 Uniform and Equipment

The appointed service provider shall ensure that all deployed security officers and supervisors are issued with the following:

9.3.1 Company-Branded Uniforms

9.4 **Control Room**

9.4.1 **Establishment and Location**

The appointed service provider shall maintain a fully operational control room within a 50-kilometre radius of the Stellenbosch Municipality. In the event that the service provider does not have such a facility at the time of award, it shall establish, equip, and fully commission a control room within three (3) months of the award of the contract.

9.4.2 **Non-Compliance and Penalties**

Failure to establish a fully operational control room within the prescribed three-month period shall result in the imposition of penalties in accordance with the penalty clause. Continued non-compliance beyond this period shall constitute grounds for contract termination at the sole discretion of the Municipality, without prejudice to any other rights or remedies available under the contract or applicable law.

9.4.3 Inspection and Compliance

The control room shall be available and ready for inspection by the Municipality or its appointed representatives. Such inspections may occur during normal business hours or at any mutually agreed time. The service provider shall ensure that the control room is adequately staffed, properly equipped, and fully compliant with all operational, safety, and regulatory standards at all times.

10 GENERAL CONDITIONS

10.1 Coordination of Operations

All operational activities shall be coordinated exclusively through the Deputy Chief of Law Enforcement Operations or their duly appointed delegate. Under no circumstances shall independent or unauthorized operations be undertaken.

10.2 Confidentiality

All information, reports, and images obtained during the execution of services under this contract are deemed confidential. Such materials may not be shared, published, or distributed without the prior written consent of Stellenbosch Municipality.

10.3 Labour Contract

Security officers engaged under this contract shall not, at any time during the contract period, stage or participate in any form of illegal labour action, including but not limited to stay-aways, go-slow strikes, or any other activity that may negatively impact the operations of Stellenbosch Municipality.

10.4 Supervision and Communication

Security officers shall be subject to proper supervision at all times. Supervisors must be equipped with effective communication tools enabling direct contact with:

- The service provider's operations room, and
- Security officers deployed across municipal properties.

The service provider shall ensure timely response to all calls for assistance received from deployed personnel.

10.5 Personnel Dissatisfaction

In the event that Stellenbosch Municipality expresses dissatisfaction with any member of the security personnel, the Municipality shall notify the service provider in writing. Upon receipt of such notice, the service provider shall:

- Immediately remove the identified personnel from duty, and
- Provide a suitably qualified and trained replacement without delay.

10.7 Binding Conditions

10.8 Incorporation of Conditions into Service Level Agreement

In the event that a bidder's proposal is successful and formally accepted, all terms, conditions, and requirements contained within this bid document shall automatically be incorporated into, and form an integral part of, the eventual Service Level Agreement (SLA) concluded between Stellenbosch Municipality and the successful bidder.

- 10.9 In the event that the Stellenbosch Municipality is dissatisfied with any member of the security personnel provided by the service provider, the Municipality shall notify the service provider in writing. Upon receipt of such notice, the service provider shall immediately remove the identified personnel from duty and provide a suitably qualified and trained replacement without delay. The Stellenbosch Municipality shall not be obliged to provide reasons for its dissatisfaction. Any personnel removed in terms of this clause shall not be deployed at any municipal site under this contract for the remainder of the contract period.

- 10.10 The service provider, or a duly authorised representative capable of making decisions and acting on behalf of the service provider, shall attend a weekly operational meeting with the Deputy Chief of Law Enforcement Operations or his/her delegated representative. In addition, a monthly performance and compliance meeting shall be held with designated officials of the relevant department(s). Failure to do so, will be regarded as a deficiency in terms of the penalty clause within this document.

11 PENALTIES

- 11.1 The penalties outlined in this section shall apply for the full duration of the contract.
- 11.2 Penalties imposed on the service provider in terms of this contract shall be deducted by the Stellenbosch Municipality from monthly payments due to the service provider.
- 11.3 Should the appointed service provider repeatedly fail to meet contractual requirements, operational obligations, or performance standards as stipulated in this tender and the Service Level Agreement (SLA), the following enforcement steps shall apply:
- In the event of continuous non-compliance or repeated breaches occurring within the first three (3) months of service delivery, the Municipality shall issue a formal written warning and may require the service provider to implement and submit a corrective action plan within a specified timeframe.
 - Should non-compliance persist beyond three (3) months from the date of the first written warning, or should the service provider fail to demonstrate measurable and sustained improvement, the Municipality reserves the right to:
 - Impose additional financial penalties.
 - Suspend portions of the contract; or
 - Terminate the contract and immediately appoint the secondary bidder to assume service delivery.

- 12.6 The signed verification document referenced in Clause 12.5 shall be submitted together with any weekly and monthly reports and must correspond with the recorded number of structures/dwellings demolished.

13. INFORMAL SETTLEMENTS

- The appointed service provider shall familiarize themselves with the informal settlement areas listed under this contract. Additional areas not specified herein may also be subject to illegal occupation or attempted invasion. In such instances, and where instructed by the User Department, the service provider may be required, on an as-and-when-needed basis, to assist in the monitoring and prevention of land invasion.
